The conference, a collaborative endeavor of NCLA and the Southeastern Library Association, will be held in Charlotte, November 9-13, 2004. It promises to be both festive and productive.

At the end of my tenure, I hope to have delivered to you an insightful report on our organization, a meaningful strategic plan, a list of consequential connections with allied professionals, and a successful Centennial conference and celebration.

I trust that *all* of our efforts will enhance and advance the entire library community of North Carolina. I am honored to serve you and I enthusiastically look forward to a successful new biennium.
